- 2 The Corporation has decided to invite the Expression of Interest from well experienced & reputed Travel Agencies/Service Providers & Others) in the form of two bid system (Technical Bid & Financial Bid) for empanelment. The technical bid opened first shall be evaluated and only qualified bidders shall be considered for participation in the financial bid.

3 Invitation of Expression of Interest

- 1 The EOIs are invited from all reputed, experienced & financially sound agencies/service providers/ organisations for operation of good quality vehicles (Hatchback/Sedan/Muv/Suv etc.) for a period of **5 years**. The same shall stand renewed automatically unless otherwise terminated by either of the party issuing a clear notice of termination as per termination clause or till there is a subsisting contract for services of agency on overall satisfactory services, who fulfil the following Eligibility Criteria:
 - (a) The operator/agencies shall have a minimum of three years of similar experience for the operation of similar class of services.
 - (b) The company should have an average annual turnover of Rs. 5 lakhs in last three preceding financial years till FY 2017-18 to be certified by a Chartered Accountant based on audited financial statement.
 - (c) The bidder should not have been declared insolvent by any court of Law in India.
 - (d) The Bidder must be well established and must have supplied or plying vehicles on hiring mode for at least three years either in single or multiple orders with satisfactory performance.
 - (e) Bids from consortiums/joint ventures are allowed.

4. Terms & conditions General

- I. The BSTDC Ltd is authorised to provide commercial vehicles on demand from government Department/other tourist.
- II. The BSTDC Ltd willing to invite expression of interest for supply of various vehicles as per details mentioned in **Annexure-A** (**Technical Bid**) from service providers.
- III. The mode of operation of vehicles for government department/other tourist will be on the basis of received financial bid as per **Annexure B** by BSTDC. Some of the broad parameters of the proposed scheme are as under:
 - i. Successful bidders will be empanelled on the basis of lowest price quoted in descending order. If more than one bidder quoted the same price then in the empanelment precedence will be given to that bidder who has given more vehicles which are in respective category. In case the numbers are same, the one who has higher turnover will take the preference. Tenure/validity of empanelment will be for the period of 5 years. The same shall stand renewed automatically unless otherwise terminated by either of the party issuing a clear notice of termination as per termination clause or till there is a subsisting contract for services of agency.
 - ii. Notwithstanding empanelment of agencies of successful bidders. Other agencies who fulfil the terms and conditions stipulated in Expression of Interest can apply for empanelment even after completion of this EOI but agency is ought to accept the price derived for vehicles for which they are applying for empanelment. Hence they will place below the empanelled list already prepared in ascending order at the end of the bids process in first come first serve basis i.e. the one who come first will be given precedence once the one who apply later.
 - iii. All successful bidders qualified with technical & financial other than L1 will be arranged in ascending order as per their rate for particular vehicles model and given chance to empanelment in next 7 days after L1 is decided. If they accept the rate as quoted by L1, they will be given position in empanelment list as they appeared in financial bid (i.e. L2,L3, L4 as on).
 - iv. The entire algorithm/process will be managed by in-house software of BSTDC Ltd and e-billing system and log book will be maintained & updated through software of BSTDC Ltd.
 - v. All the empanelled agencies will have to provide vehicle as per L1 rate.
 - vi. All empanelled agency will have to enter into written agreement as per the terms and conditions decided by the BSTDC Ltd.
 - vii. BSTDC Ltd reserves the right to accept or reject any or all or any part of the tender without assigning any reason thereof, and the decision of BSTDC, Patna in this respect shall be final.
 - viii. The BSTDC Ltd shall reserved the right for supply of vehicle to department/other in case of urgent requirement through its own sources. (The decision for urgency and its time shall be sole discretion of BSTDC Ltd and empanelled agency will have no right of objection in this regard.
 - ix. The BSTDC Ltd alone shall have the rights to increase rate/tariff of vehicles (as and when required) based on market demand.
 - x. The BSTDC Ltd shall have the rights to add /remove/revise list of vehicles based on market scenario and the vehicle(s) which will be removed from the list, then agencies empanelled will become null & void.
 - xi. The BSTDC Ltd shall have right to modify the eligibility criteria as mentioned in clause 3 of this EOI, in future as deemed fit by the BSTDC Ltd.

- xii. The BSTDC Ltd will open a window of 24 hours for supply of vehicles as per requirement of departments/others and asked/request to all empanelled agencies to supply/provide such kind of vehicles through such window with nos. of vehicles in that categories and selection of agency for fulfilment of such requisition will be according to list of empanelled agencies.
- xiii. Requisition of Vehicle will be given to the empanelled agency according to their position in the list, i.e. L1 thereafter in descending order. The service providers will provide efficient, comfortable, courteous and well-disciplined and well appointed staff for vehicle services to BSTDC Ltd. for further services of its dept/tourists.
- xiv. While all attempts shall be made by The BSTDC Ltd to achieve the overall booking /occupancy of vehicles, no responsibility whatsoever shall be attributed to and no liability whatsoever shall be claimed from the the BSTDC Ltd in the event of any loss.
- xv. The BSTDC Ltd shall have the right to accept or reject any operating staff provided by the Service providers with/without assigning any reason.
- xvi. The Service providers shall ensure good condition of the vehicle all the time during the operation and it should be stationed at its starting point at least 30 minutes before every scheduled departure of the vehicles.
- xvii. The Service providers shall deposit with the BSTDC Ltd, all the necessary documents required under rules of the government/governments and also as and when demanded by the BSTDC Ltd in operating these vehicles including documents pertaining to its operating staffs such as driver(s).
- xviii. Global Positioning System (GPS) shall be installed in all vehicles and must be with tracking system where access should be given to BSTDC Ltd. In future, BSTDC Ltd will also provide the vehicle tracking system to empanelled agencies which must be used in their vehicles on their own cost.
- xix. Though the contract shall be awarded for a period as mentioned in clause 3 (1) of this EOI initially but a department/others feedback system shall be created and the quality of feedback of the travellers shall form an important basis for continuance of the services. In case the quality of services/ complaint redressal system is not found to be of good level the concerned agency will be delisted from empanelled list after giving a notice period of 7 (seven) days and agreement entered into with the said agency will be terminated. In such case the list of empanelment will be auto shifted up to vacant place by moving one by one
- xx. The staffs of the vehicles that will remain well dressed and courteous to all the passengers & shall at all times remain the employee of the service providers and in no way an employer employee relationship can arise with The BSTDC Ltd.
- xxi. Staff will at no time consume any intoxicating substance like alcohol, pan, tobacco, Gutka etc during the period he is assigned to operate the vehicles in such manner that it affects his performance as the driver of the vehicles in the opinion of the Managing Director or the nominated person to inspect the vehicles or generally to look after the operations of the vehicles.
- xxii. All labour laws and other statutory provisions with respect to the employees deployed shall be complied wit by the service providers.
- xxiii. The Applicant should have its own GST no. and will not be reimbursed, if the Service Provider fails to produce proof of payment of GST.
- xxiv. The billing will be done on monthly basis and bills to be submitted in triplicate by the 5th of the succeeding month.
- xxv. The vehicle provided should comply with laws in force in India.
- xxvi. The driver should have valid driving license and comply with all the relevant laws in force and he should be adequately experienced, and maintain decency, politeness, neat dress and good habits.

- xxvii. The driver should be equipped with a functional mobile phone with GPS facilities at his own/service provider's cost. Driver should be well acquainted with the routes and locations of entire Patna and Bihar. Driver/service provider shall maintain log-book with vehicle indicating the day to day running mileage.
- xxviii. Once hired, the vehicle will not be put to use for any other purpose and the vehicle and driver will work under the overall supervision of the B.S.T.D.C.
- xxix. In order to ensure day to day functionality of hirer, service provider shall not keep changing or rotating vehicle and driver, except if the hirer so indicates in case of any eventuality or unsuitability.
- xxx. The service provider/Agency will comply with labor laws in force and all liabilities related with that.
- xxxi. The BSTDC Ltd will not be under any obligation, legal or otherwise, to provide employment to any of the personnel of the service provider during or after the expiry of the hire period. The BSTDC Ltd recognizes no employer-employee relationship between the BSTDC Ltd and the personnel deployed by the service provider. The BSTDC Ltd shall not be responsible financially or otherwise for injury to the vehicle or driver or person deployed by the service provider during the course of hire.
- xxxii. In case of any accident, all the claims and damages arising there from shall be met by the service provider.
- xxxiii. The vehicles that is new or not less than 3 years old and should be without any accident history, in excellent and neat exterior, interior, interior and running condition and the same should also be maintained during period of hire.
- xxxiv. The vehicle shall be provided on any day including Saturday, Sunday and Holidays, if required by the hirer. No extra payment will be made for providing the vehicle on Saturday, Sunday and Holidays.
- xxxv. Zero based mileage i.e. mileage starting and ending at/from duty or drop off location shall be adopted for the purposes of calculating the kilo meters and starting and ending place shall be decided by BSTDC.

- (iv) Try to influence BSTDCL or any of its officials in relation to the evaluation of bids;
 BSTDC Ltd shall have the right to forfeit their EMD and blacklist them from participating in any future tenders issued by BSTDC Ltd.
- 13. BSTDC Ltd may, at its sole discretion, extend the bid due date and amend the tender by amending the tender documents. In such a case, all rights and obligations of BSTDC Ltd and bidders previously subject to the bid due date will thereafter be subject to the bid due date as extended.
