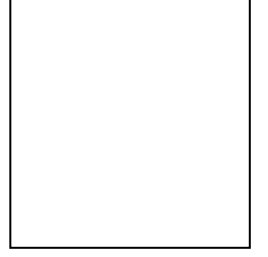
## Terms & Conditions and Rule For Sale of Old Vehicles

1. The highest quoted bidder will be required to deposit the full amount within 15(fifteen) days. If they fail to deposit the full amount within time, their earnest money & other deposit amount if any will be forfeited & the tender /bidder will be black listed for three years.
2. That the sold vehicle will be delivered to the successful bidder /quotationer without documents like surrender slip etc. They will be required to obtain those documents from the respective Transport Authorities at their own cost.
3. That the successful bidder /quotationer/bidder will be required to remove the sold vehicles from the premises of Bihar State Tourism Development Corporation within 7 (seven) working days from the date of full and final payment failing which ground rent 0.1%(Zero point one percent) of the balance quoted value per day per vehicle will be charged extra. If they will fail to remove sold vehicles within 30 (Thirty) working days from the date of full and final payment, entire money deposited shall stand forfeited and the sold vehicles and unserviceable materials would be disposed of without any notice to the defaulting bidder /quotationer who shall have no claim what so ever.
