- 21. The bidder must use File size should be less than 5 MB and should be in PDF and JPEG formats.
- 22. No claim shall be entertained on account of disruption of internet service being used by bidders. Bidders are advised to upload their bids well in advance to avoid last hour's technical snags.
- 23. Bids that are rejected during the bid opening process shall not be considered for further valuation, irrespective of the circumstances.
