- 17. Architect Consultants empanelled with BSTDC vide NIT- 14/RFP/2021-22 & 03/RFP/2022-23 are not required to submit their bids. Their Registration for empanelment with BSTDC, Patna will remain unchanged. With condition that they have to agree all clause of current RFP for empanelment
- 18. Earnest Money should be paid through online mode i.e. internet payment gateway (Credit/Debit card), Net Banking, NEFT/RTGS or by BG in favour /pledged Bihar State Tourism Development Corporation Ltd. (BSTDC Ltd), and hard copy shall be in the form as explained in the terms and conditions available in Tender free view at the website. Original earnest money shall be submitted to the office of Executive Engineer, Bihar State Tourism Development Corporation Ltd. - 20. The authority shall have the right to reject the bid partially or fully without assigning any reason what so ever.
- 21. The bidders are requested to check their file size of uploaded documents at the time of submission & they should ensure that work file is uploaded if they feel that the complete file is not uploaded then they should click on cancel & update the same before submission. The bidders should satisfy themselves of download ability/visibility of the scanned & uploaded file by them.
- 22. The bidder must use File size should be less than 5 MB and should be in PDF and JPEG formats.
- 23. No claim shall be entertained on account of disruption of internet service being used by bidders. Bidders are advised to upload their bids well in advance to avoid last hour's technical snags.
- 24. Bids that are rejected during the bid opening process shall not be considered for further evaluation, irrespective of the circumstances.
- 25. The bidders shall submit their eligibility and qualification details, Technical bid, Financial bid etc, in the online standard formats given for respective tenders in e-Procurement website (www.eproc2.bihar.gov.in) at the respective stage only. The bidders shall upload the scanned copies of all the relevant certificates, documents etc, in support of their eligibility criteria/technical bids and other certificate/documents in the e-Procurement website The bidder shall sign on the supporting statements, documents, certificates, uploaded by him, owning responsibility for their correctness/authenticity.
