- 18. There is no ceiling / limit for going below the BOQ rate for percentage rate tenders as per RCD latter no 447(S) Date- 16.01.2020 but will have to deposit additional performance guarantee needed as per direction.
- **19.** All the information/corrigendum/addendum related to the project shall be published on the website www.eproc2.bihar.gov.in / BSTDC website. The authority shall have the right to reject the bid partially or fully without assigning any reason what so ever.
