In Payment mode of Earnest Money deposit Online/Offline (Only Bank Guarantee) instrument will be valid as EMD (As per RCD Lt no. 5651(E) Dt. 19-08-2020) BG of Nationalized/ scheduled bank shall be submitted. duly endorsed/pledged to the Executive Engineer Bihar State Tourism Development Corporation Ltd. Patna, The BG shall be issued on/after the Start date of uploading the bid document. It should be valid for not less than 180 days.
 7. The successful Bidder at the end of the Bidding process may be awarded a contract by BSTDC Ltd. to implement the project on EPC Mode. The contractor (the successful Bidder) shall be responsible for the Design, Engineering, Procurement, Construction and Maintenance of the project in terms of the agreement to be signed between the Contractor and Executive Engineer Bihar State Tourism Development Corporation Ltd. Patna.
