The department does not take any responsibility for the delay/Non availability of internet connection, Network Traffic/Holidays or any other reasons".
13. **Earnest Money should be paid through online mode i.e. internet payment gateway (Credit/Debit card), Net Banking, NEFT/RTGS or by BG in favour /pledged Bihar State Tourism Development Corporation Ltd. (BSTDC Ltd), and hard copy shall be paid in the form as explained in the terms and conditions available in Tender free view at the website. Original earnest money shall be submitted to the office of Executive Engineer, Bihar State Tourism Development Corporation Ltd. (BSTDC Ltd), 4th Floor, Sikh Heritage Building, Daroga Prasad Rai Path, Patna– 800 001, till last date and time of Opening Technical bid, failing which the tender will be rejected.**
14. The bidders are requested to check their file size of uploaded documents at the time of submission & they should ensure that work file is uploaded. If they feel that the complete file is not uploaded then they should click on cancel & update the same before submission. The bidders should satisfy themselves of download ability/visibility of the scanned & uploaded file by them.
15. The bidder must use File size that should be less than 5 MB and should be in PDF and JPEG formats.
16. No claim shall be entertained on account of disruption of internet service being used by bidders. Bidders are advised to upload their bids well in advance to avoid last hour's technical snags.
17. Bids that are rejected during the bid opening process shall not be considered for further evaluation, irrespective of the circumstances.
18. The bidders shall submit their Technical bid, financial bid etc, in the online standard formats given for respective tenders in e-Procurement website (www.eproc2.bihar.gov.in) at the respective stage only. The bidders shall upload the scanned copies of all the relevant certificates, documents etc, in support of their eligibility criteria/technical bids and other certificate/documents in the e-Procurement website. The bidder shall sign on the supporting statements, documents, certificates, uploaded by him, owning responsibility for their correctness/authenticity.
19. All the information/corrigendum/addendum related to the project shall be published on the website www.eproc2.bihar.gov.in. The Authority shall have the right to reject the bid partially or fully without assigning any reason what so ever.
20. In order to assess the actual work content, intended bidder firms has to visit the site to familiarize them with the existing plant condition, prior to submitting bid. For this no extra compensation shall be payable.
21. All intending bidders are required to submit their price as per Annexure duly filled up with lump sum quote, both in figures and words. This is to be properly signed and stamped.
